The Board of Mayor and City Commissioners met in a regularly City Meeting on January 12<sup>th</sup>, 2021.

A **Motion** was made Commissioner Stone, **seconded** by Mayor Kellermann, to **approve the minutes of the meetings** on November 10<sup>th</sup>, November 30<sup>th</sup> and December 21<sup>st</sup>, 2020. Roll call vote: Commissioner Kellermann, yes; Commissioner Buchanan, yes; Commissioner Stone, Yes; Vice Mayor Lancaster, yes; Mayor Rector, yes. Five voted ayes.

#### **Comments from Mayor:**

After a Recommendation from Mayor Rector, A **motion** was made by Vice Mayor Lancaster, **seconded** by Mayor Rector, to **appoint Commissioner Stone to the Planning Commission and Zoning Board to replace Commissioner Haley**. Roll call vote: Commissioner Kellermann, yes; Commissioner Buchanan, yes; Commissioner Stone, abstain; Vice Mayor Lancaster, yes; Mayor Rector, yes. Four voted ayes.

After a recommendation from Mayor Rector, A **motion** was made by Vice Mayor Lancaster, **seconded** by Mayor Rector, **to appoint Jimmy Lovelady to replace Ed Reynolds (due to Death) on the Marion Natural Gas and Water Board**. Mayor Rector appointed Commissioner Kellermann to be the Department Head for the Library and Commissioner Buchanan as the Department Head for the Fire Department.

Mayor Rector then advised Marion County Newspaper's publisher that his parking signs would need to be removed.

Mayor Rector discussed furthering enforcing the City of South Pittsburg's Leash Law.

Mayor Rector mentioned the Resolution 1012 on Flood Mitigation that the County will now be more involved, not responsible but will help in the flooding Issues.

Mayor Rector asked City Administrator Gene Vess that if an employee gets called in on a holiday would this be considered straight time.
