### **Comments from Commissioner Kellermann:**

Commissioner Kellermann commented that herself, the City Administrator, and 2 of the Public Works Crew meet with Urban Forestor to learn proper ways of cutting and preserving the Downtown trees.

Commissioner Kellermann discussed the Moore Park updates, will be a applying for a grant to cover new equipment for Moore park. A survey will be added to the City's Facebook and webpage for community imput on the Moore Park updates.

Commissioner Kellermann advised the Downtown Fountain repairs are still in the works and are closed to being finished.

A motion was made by Mayor Rector, seconded by Commissoner Stone to approve the 1<sup>st</sup> Reading - Ordinance 822- Ordinance Amending the Annual Budget for The City Of South Pittsburg, Tennessee For Fiscal Year 2021-2022. A motion was made by Mayor Rectorm seconded by Commissioner Buchanan to approve **Resolution 1016** – A Resolution of the City of South Pittsburg Board of Mayor and Commissioners Authorizing an **Application For Funding Under The Bluecross Healthy Place Grant.** Commissioner Kellermann, yes; Commissioner Buchanan, yes; Commissioner Stone, Yes; Vice Mayor Lancaster, yes; Mayor Rector, yes. Five voted ayes.

A motion was made by Mayor Rector, seconded by Commissioner Kellermann to approve, a refund to In the tax sale held on November 9, 2018, the property located at 210 Hamburg was sold for delinquent City property taxes to Shannon Ball. Ms. Ball paid a total of \$1,441.51, with \$1014.78 of that payment going to the City and the remainder going to the County Trustee for the County's 2018 taxes and expenses of the sale. During the one-year redemption period after the sale, the property owners filed bankruptcy, which required that the sale be set aside and all monies be refunded to the purchaser. By law, Ms. Ball is entitled to a refund of her purchase price plus 10% interest on that amount through the date of the refund. That refund must be approved by the Board of Mayor and Commissioners even though it is a relatively small amount. Based on my calculations, the total amount due to Ms. Ball from the City is \$1,294.73, which is the original payment amount of \$1,014.78 plus interest of \$279.95. calculated through August 13, 2021. meeting, and I will be glad to explain the process and

answer any questions. The remainder of Ms. Ball's refund will come from the County. Commissioner Kellermann, yes; Commissioner Buchanan, yes; Commissioner Stone, Yes; Vice Mayor Lancaster, yes; Mayor Rector, yes. Five voted ayes.
